

AN ORDINANCE

levying an ad valorem tax for maintenance of the Comanche Independent School District
for the year 2016.

BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE COMANCHE INDEPENDENT SCHOOL DISTRICT:

Section 1. The following ad valorem tax for the year 2016 is hereby levied by and for the Comanche Independent School District on all property located within the district:

Maintenance and Operations	\$1.17	per \$100 assessed valuation
Debt Service	\$0.07973	per \$100 assessed valuation
Total Tax Rate	\$1.24973	per \$100 assessed valuation

No discounts are authorized for early payment.

Section 2. If any provision of this Ordinance or the application thereof to any person or circumstance is held to be invalid, such invalidity shall not affect other provisions or applications of the Ordinance which can be given effect without the invalid provision or application, and to this end the provisions of this ordinance are declared to be severable.

Section 3. If it ever should be determined by a final adjudication that the levy of the ad valorem tax for the Comanche Independent School District for the year 2016 should have been in some form other than this Ordinance, then and in that event, the above and foregoing shall be considered to have been passed, approved, and adopted by the Board of Trustees of Comanche Independent School District as a Resolution or an Order or in whatever form is legally necessary to levy such ad valorem tax.
